

1. Introduction



- 1.2. Lithuanian Football Federation (hereinafter "LFF") intends to build up to 4 pitches with artificial turf FIFA quality PRO certificate in various places in Lithuania during next two years. The exact places for these installations will be defined in the course of the mentioned period. It is planned to install from 2 to 3 pitches in 2018. - 1.3. Lithuanian Football Federation (hereinafter "LFF") intends to build up to 13 small (1000m²) pitches with artificial turf in various places in Lithuania during next two years. The exact places for these installations will be defined in the course of the mentioned period. Annex No. 2 (2 pages).
- 1.4. Purchase of the artificial turf is subject to the financing received by LFF from UEFA in accordance with UEFA Hat Trick IV investment program.
- 1.5. The purchaser of the turf will be LFF. The company, which will supply the artificial turf, will have also to fulfill its obligations indicated in the Project Agreement, which is attached to this invitation to submit offers (hereinafter the "Invitation").
- 1.6. The civil work, sub-base installation, purchase of in-fill and artificial turf installation work done by specialized companies will be under the direction of the Municipalities and supervision of LFF. The Bidder has an obligation to give technical assistance and support, and present strict recommendations with know-how to the Municipalities during and for civil works, turf and elastic layer installations, purchase of in-fill as well as to the local specialized companies in question during the installation.

- 3.4. Bidder is allowed to submit only one Offer for each part of the Tender (one for the full size pitch project, another for the small pitch project; any subsequent Offers shall be automatically rejected.
- 3.5. All Offers shall be in the English language (including all annexes and any correspondence related to this Invitation). The Offer shall be signed by duly authorised person(s) of the bidder. No oral information will be taken into consideration.

- 3.7. LFF may, at its own discretion, change the Closing Date and Time by adding additional time. Since time is of essence, additional time will, however, only be added in extreme circumstances. Any such change shall apply to all bidders.
